Job Title:	Regional Lead – Children's Homes (Children & Young People Division)
Salary:	£70,000 + £2,000 car allowance per annum
Hours of Work:	38 hours per week with some evenings and weekends required
Location:	MacIntyre School and Children's Homes, Wingrave, Buckinghamshire

This vital role provides strategic leadership and oversight across five children's homes, supporting around 28 children and young people aged 9–18. Young people have learning disabilities and/or are autistic.

You will ensure that children experience safe, nurturing homes where their rights, voices and individuality are respected, and where care is delivered in line with MacIntyre's Purpose, DNA and values, while fully meeting Ofsted and legislative requirements.

About you

You will need:

- Significant experience as a Registered Manager with strong Ofsted outcomes
- An understanding of what great children's residential care looks like in practice
- The ability to lead, support and challenge services to continuously improve
- To shares MacIntyre's values and commitment to children living lives that make sense to them

Our vision is for all people with a learning disability and/or autism to live a life that makes sense to them.

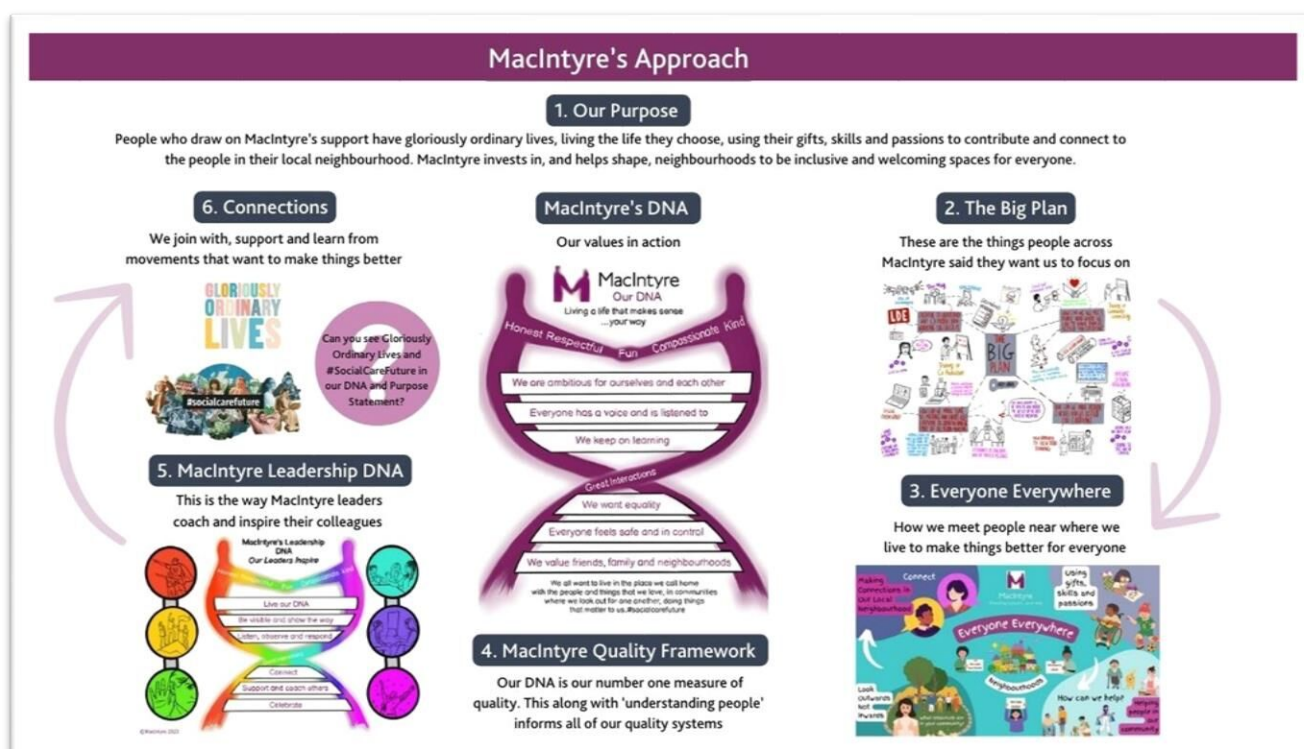
Our Purpose

Purpose

At MacIntyre, we work so that children and young people can live gloriously ordinary lives that make sense to them.

The Registered Individual is accountable for the overall quality, safety and regulatory compliance of MacIntyre's children's residential homes.

This role provides strategic leadership and oversight across five children's homes, supporting around 28 children and young people aged 9–18.

The role ensures that children experience safe, nurturing homes where their rights, voices and individuality are respected, and where care is delivered in line with MacIntyre's Purpose, DNA and values, while fully meeting Ofsted and legislative requirements.

The role will contribute to the strategic direction of MacIntyre School, Children's Homes, and No Limits as part of the Senior Leadership Team (SLT)



What the role involves

People

- Holding clear accountability for the quality of care and outcomes experienced by children and young people living in MacIntyre homes
- Ensuring children are safe, listened to and supported to live lives that reflect their wishes, strengths and aspirations
- Embedding Everyone Everywhere and Gloriously Ordinary Lives into day-to-day practice across all homes
- Overseeing safeguarding practice to ensure children's welfare is always prioritised
- Supporting Registered Managers to ensure children's care plans, risk assessments and support approaches are personalised and responsive
- Promoting children's participation, independence and positive transitions, including admissions, moves and future planning

Workforce

- Providing leadership, support and performance management to Registered Managers across all children's homes
- Ensuring safer recruitment practices are in place and that teams have the right skills, values and experience
- Supporting a positive culture where staff feel valued, listened to and developed
- Ensuring effective supervision, appraisal and reflective practice is embedded
- Overseeing training, development and learning to ensure staff are confident, skilled and trauma-informed
- Promoting staff wellbeing, resilience and stability across services

Compliance

- Acting as the Registered Individual with Ofsted for all children's homes
- Ensuring services operate in line with the Children's Homes (England) Regulations 2015 and relevant legislation
- Maintaining oversight of Ofsted inspections and supporting homes to achieve and sustain Good or Outstanding outcomes
- Ensuring notifiable events are reported appropriately and within required timescales
- Maintaining oversight of safeguarding, health and safety, medication and risk management systems
- Ensuring mandatory training, safer recruitment and regulatory processes are robust and monitored

Sustainability

- Ensuring homes operate within agreed budgets while maintaining high-quality, safe care
- Overseeing staffing structures, rotas and resourcing to meet children's needs
- Supporting effective commissioning relationships and engagement with local authorities
- Contributing to the long-term sustainability and development of MacIntyre's children's services
- Supporting organisational planning in line with The Big Plan and Everyone Everywhere
- Representing MacIntyre positively with commissioners, partners and external stakeholders

- Promoting consistent, high-quality practice across all homes
- Working closely with families, carers and professionals to support positive outcomes for children
- Championing trauma-informed and therapeutic approaches to residential care
- Working in partnership with internal teams to support best practice, learning and improvement
