## What is the difference between a VODG member and a VODG strategic partner, partner or affiliate?

Members of VODG are non-profit organisations directly supporting disabled people. VODG strategic partners, partners, and affiliates offer professional services or products and have a stake in the sector.

## Will you recommend my business and services to your members?

Yes, we may consider fulfilling a specific request from a member if we believe that your company is the best fit for their needs. This is not a part of the VODG corporate partnership offering, but rather a service that we provide regularly on an ad hoc basis.

### Will I get the chance to network with your members?

Depending on your package, yes, you will. All events are open to members to attend, and we strive to incorporate networking time into our sessions when possible. We also aim to facilitate open discussions as part of our events to encourage knowledge sharing and debate.

#### Will you share your member contact list with us?

No, however, our members are clearly listed on our website, and there is also the opportunity to network at applicable events and conferences.

### How many members of my organisation can attend VODG events?

The number of delegates per organisation entirely depends on our venue capacity and your partnership package. However, if we do have to restrict attendance to one delegate per organisation, we will operate a waiting list for any additional members of staff who wish to attend.
